DISTRICT AND COUNTY COUNCILLORS REPORTS

- 223/19 J Burr (Mendip District Councillor) reported as follows:
 - Talk will be given at the Council on Climate Change on 27th September at Shape Mendip
 - Parish Forum is tomorrow. Councillors and Clerks encouraged to attend.
 - County Parking Strategy Consultation coming out soon, which will extend to villages as well as towns.
 - Shepton Mallet Library update.
- 224/19 M Pullin (County Councillor) reported as follows:
 - Not much happening at the moment.
 - There is a small SIS in the works to spend £80k for more lines, signs and painting on the road at the Beacons Crossroads. It was felt that the money should be put back in the pot and saved to fund a proper solution, like a roundabout. Mike is in discussion with the local quarry, trying to push this idea forward. It was agreed to fully support any move to implement a roundabout or any other solution.

OAKHILL CROSSING AND PARKING AT THE SCHOOL

- The project is completed and comments are generally positive, however, issues have arisen as a result:
 - The hump at the top of the High Street has been removed. It was originally put
 there following flooding in the High Street. Highways responded that the hump was
 incorporated into the design but was less obvious, and that draining on the High
 Street and the A367 has also been improved. Some gulleys will be further cleared to
 ensure proper drainage. Josh asked that gulleys in Fosse Road are also cleared at
 the same time.

Residents do not believe what has been done will prevent flooding and will be monitoring closely. Cllr M. Pullin asked that residents and Parish Council keep in touch after rain and heavy rain with photos and comments to monitor the situation.

 Parking; Due to movement of cars in the High Street, some residents now have to park quite a way away from their houses and noted that the High Street was quite dark when walking back at night. Clerk to write to Highways, copying Mike, to request for additional lighting in the High Street, in the area near the flower bed.

- The offer of parking at the school has been withdrawn due to building work at the school at the moment. Might consider it again later, although it is wondered whether there would be liability issues.
- Space in front of BT exchange could we rent the land? D Gilson recalled contacting BT back in March 2017 and the following was recorded in the minutes:

Hotspot times and response time data was queried, and raised concerns over large number of historical buildings in Wells.
