- (c) 2022/0523/TCA T1 Silver Birch Crown lift to 3.5m. T2 English Oak Crown lift to 3.5m. T3 Beech Crown lift to 3.5m, crown reduction to 4m. Pondsmead Surgery, Bath Road, Oakhill **Update** The recommendation was to leave the decision to the tree officer.
- (d) 2022/0593/FUL Erection of stable block, stone and creation of track from existing access, land at 364750 148150. Nettlebridge Hill, Bath Road, Oakhill. Update Following a discussion further information was requested before an informed decision could be made.
- **(e) 2022/0406/FUL** Erection of Garage/Carport (Retrospective). Land West of Kingscombe, Gurney Slade. **Update** Ashwick Parish Council recommended approval.
- **(f)** New Premises Licence Application for a premises licence for Mendip Golf Club Ltd, Mendip Golf Club, Golf Links Lane, Ashwick. **Update** Ashwick Parish Council had no objections and recommended approval.
- **(g)** Proposed Diversion of public footpath SM 1/60 in the parish of Ashwick. **Update** Following a long discussion, Ashwick Parish Council responded in agreement to diverting the footpath for health and safety reasons but to keep the original path open as it is well used.

## 11 To Be Resolved/Discussed

(a) Discussion on the cost of purchasing a tree to celebrate the Platinum Jubilee and whether the Village Hall Committee have agreed to the tree being planted in the Playing Fields

Cllr Andy Clements had obtained a quote for £200 for an Oak tree. The Village Hall Committee have agreed to the tree being planted in the Playing Fields although the actual location is yet to be confirmed. The Council **RESOLVED** to agree a budget of £200 for purchase of an Oak Tree. Chew Valley Trees will be contacted for advice.

(b) Discussion on the installation of a new bus stop at Nettlebridge, this has been requested again by a resident.

This was discussed and the potential bus shelters within the village of Oakhill. First Bus has been contacted and the Parish Council is waiting for confirmation of bus stops and information. Once the elections are over in May the new Unitary Councillor will be contacted to help push this forward.

# **12 Clerks Report**

(a) A response was received from Somerset County Council as to the inconsiderate parking in the layby on the A367 Bath Road outside Withy Cottages. Somerset County Council have no powers to stop or prosecute the drivers of vehicles parking in this manner. Any vehicle which is taxed and insured, is able to pass or park on the public highway.
