Update The Parish Council recommended the decision be left to the Planning Officer but with comments raising the issues of the parking
 - (b) 2023/0190/HSE Creation of a 6m x 10.5 decking. Oakhill Lodge, Bath Road, Oakhill Update The Parish Council recommended the decision be left to the Planning Officer.
- 10 Planning Applications Responses to be noted from Mendip District Council and others.
 - (a) 2022/2350/HSE Erection of a single storey rear extension and conversion of utility room to ensuite bathroom. Laburnum, Zion Hill to Underhill, Ashwick. Mendip District Council granted approval.
 - (b) 2022/2408/FUL Erection of 1no. detached dwelling with associated access and parking. 15 Sunnymead, Oakhill. Update The application has been withdrawn.

(b) Discussion and any possible proposals on how the Parish Council wish to proceed with the second stage of the Appeal Hearing. The initial date for the Public Inquiry has been set as Tuesday 18th April.

This was discussed and it was agreed in principle to appoint the Planning Consultant and Highways Consultant to attend the appeal hearing and represent the Parish Council. Cllr David Thorley will contact both and obtain further information as to costs, this will be brought back to the next meeting.

Refurbishments are still occurring with the roof being the next main project, other ideas are changes to the toilets, replacement boiler, installing a sheltered area for table and chairs outside the café and some outside storage. A quote is nearly decided upon for the outside gym equipment, hopefully this will be ordered soon.
