(REVOCATION AND 30MPH SPEED LIMIT)
ORDER 2023

NOTICE is hereby given that Somerset Council proposes to make the above Order in pursuance of the provisions of the Road Traffic Regulation Act 1984, as amended, the effect of which is to introduce a 30mph Speed Limit on the lengths of road as specified in Schedule 1 to this Notice.

Somerset County Council, The County of Somerset (Little London and Fosse Road) (Oakhill) (30mph Speed Limit) Order 2016 will be revoked. The provisions of any other orders are hereby revoked but only as far as they are affected by the restrictions of this Order.

Galley Batch Lane, Oakhill, Ashwick	From the junction with Little London in a north westerly direction for a distance of 197 metres
Little London, Oakhill, Ashwick	From the junction with Chapelfield in a north westerly direction for a distance of 481 metres
Sunnymead, Oakhill, Ashwick	For its entire length
Chapelfield, Oakhill, Ashwick	For its entire length
High Street, Oakhill, Ashwick	For its entire length
The Old Maltings, Oakhill, Ashwick	For its entire length
Zion Hill, Oakhill, Ashwick	From the junction with High Street in a north westerly direction for a distance of 262 metres
Fosse Road, Oakhill, Ashwick & Stoke St Michael	From the junction with the A367 Bath Road in an easterly direction for a distance of 940 metres
A367 Bath Road, Oakhill	From the junction with High Street in a southerly direction for a distance of 191 metres and from the junction of High Street in a north easterly direction for a distance of 251 metres
